When we give, we pay the electric bill, buy music and orchestrations, and plan for Christmas celebrations that will touch our hearts.

And it's only possible when we all do our part, when we all give and pray and grow and serve. It's only possible when we all live into our role in God's blueprint for White's Chapel.

Thinking About Taxes in your Blueprint for Giving

What is your blueprint for giving? Do you have a plan? Do you plan to give but haven't yet? While many of us simply give - which is great - there may be some tax advantages to giving with a plan. And your plan for giving does not have to be a complex stack of drawings using some photosensitive ferric compound (yes, I had to look that up for Todd's benefit!). Depending upon your situation, aligning your giving with some tax considerations may be prudent.

Below are some tax basics that may help you build your blueprint for giving.

Standard Deductions and Itemized Deductions

For most individuals, there are two options for claiming deductions when computing how much of your income is subject to tax – the "standard" deduction and "itemized" deductions. The standard deduction, as implied by the name, is a set standard amount regardless of the amount of tax deductible items you may have actually had for the year (the standard deduction is inflation adjusted and for 2022, this amount is \$12,950 for singles and \$25,900 for married couples filing joint returns).

Alternatively, if you have tax deductible items (typically mortgage interest, state income and property taxes, and charitable contributions) that exceed the standard deduction, you probably want to itemize your deductions so you get a greater reduction in how much of your income is subject to tax. For those of you who historically itemize deductions, you enjoyed an incremental tax benefit to making charitable contributions. Unless your itemized

deductions exceed the now higher standard deduction, this tax benefit is not available in that year.

Cash Donations

Cash gifts are simple and assuming you can itemize deductions, the tax benefit is easy to determine as it generally reduces your income subject to tax by the amount of cash you donate. To claim a deduction in 2021, the contribution must be made on or before December 31, 2022.

Non-cash Donations

While cash is easy to donate, cash may not give you the most benefit from a tax perspective. It, of course, depends! Two "winwin" ways to donate include donating certain appreciated stock and making qualified IRA distributions. First, donating investments that might otherwise generate long-term capital gains if they were sold may allow you to claim a deduction for the fair market value of the stock without paying tax on the long-term gain as if you sold it. If you are considering harvesting some gains in your portfolio before year-end, this might be a good choice. Secondly, if you are over 70 ½, you may be able to distribute up to \$100,000 from your IRA to the church without including the distribution in income.

Donation Planning – Where a Blueprint Can Help

Alternating the Standard and Itemized Deductions

For some of you, your itemized deductions will never exceed your standard deduction. Perhaps some planning could help. While it is not always feasible, if your situation allows you to make your 2023 donations and perhaps pay other deductible expenses for

2023 in this year, your itemized deductions may exceed the standard deduction in 2022 and gain incremental tax benefit to your donations. You would then then simply use the standard deduction next year assuming your itemized tax-deductible items would be much lower. This strategy has been referred to as "doubling up," "bunching," or "grouping" your annual deductions.

Donor Advised Funds and Trusts

Perhaps you are familiar with the above, but you have recently seen a Facebook ad talking about "donor advised funds." Donor advised funds (DAF) can be useful and are very flexible. Using a DAF can simplify and accelerate your tax deductions while at the same time allow you to donate variety of more complex assets (cash donations work as well) and you can generally control the timing and recipients of the grants from the fund.

Estate and Trust Planning

For longer-term planning, there are even more opportunities to give and benefit your tax situation. While too complex to go into here, there are ways to get current deductions by using charitable trusts or similar arrangements – the income from assets can be used now by the donor but the assets are committed to the church in the future.

What about pending tax changes?

While anything is possible, major changes to the tax treatment of charitable contributions are not anticipated.

Disclaimer

As a tax guy, I probably should have had a few more "generallys" and caveats as the rules are complex. If you are unsure, ask your tax advisor or the IRS website actually has a publication discussing all aspects in mostly understandable language – simply go to www. irs.gov and search for Publication 526.
