e have been studying the Book of Genesis this year, and my mind keeps getting drawn back to Chapter 4, where we meet Adam and Eve's children: Cain and Abel. In them, we see the first recorded example of people making an offering to God. God is pleased with Abel's offering, but He has no regard for Cain's. In our studies, we explored possible reasons for God's response. The text tells us that Abel's offering from his flock was from the "firstlings" and

from their "fat portions." It's a reference to the fact that his offering was the first and the best that he had. As for Cain, there are no details about his offering or why it did not please the Lord. And it causes us to speculate: Did he give his leftovers? Did he give from his convenience or from his over-ripe fruit that was about to rot? We really don't know, but we do know that it's not only what we give, but how we give that matters to God.

Do we give to God our best? Do we offer Him our first fruits? Do we give to God first and not just wait to see what is left over? Does our giving bear evidence to what we really value the most? Our giving to God is not just about raising a church's budget. Our giving to God is a sign of our faith. It is a sign of our deepest loyalty.

Your pastors are constantly overwhelmed by the generosity of our congregation – a heart that enables us to do great things. We have people who give from the heart. Your faithfulness pleases God and allows his work to continue. Because of you, White's Chapel is the church that it is!



While not for the same reasons of course, if you are going to donate food, the IRS requires first fruits, too. Well, ok, not necessarily first fruits but certainly donating rotten tomatoes won't get you a tax write-off. Wholesome requires the food is intended for human consumption. In other words, being of benefit to the recipient and not just a deduction for the donor.

Is my donation "wholesome?" Not by IRS standards, but God's? Yes, our donations to White's Chapel fulfil the mission side. But Biblical giving desires so much more from the giver to be fully wholesome – from First Fruits, with a joyful heart, and a sacrifice. But I'll yield to our preachers to preach. I'll try to focus on the tax side! With that said, I've updated the discussion below for 2023 donations but not much has changed in this arena.

# Standard Deductions and Itemized Deductions

For most individuals, there are two options for claiming deductions when computing how much of your income is subject to tax – the "standard" deduction and "itemized" deductions. The standard deduction, as implied by the name, is a set standard amount regardless of the amount of tax deductible items you may have actually had for the year (the standard deduction is inflation adjusted and for 2023, this amount is \$13,850 for singles and \$27,700 for married couples filing joint returns).

Alternatively, if you have tax deductible items (typically mortgage interest, state income and property taxes, and charitable contributions) that exceed the standard deduction, you probably want to itemize your deductions so you get a greater reduction in how much of your income is subject to tax. For those of you who historically itemize deductions, you enjoyed an incremental tax benefit to making charitable contributions. Unless your itemized deductions exceed the now higher standard deduction, this tax benefit is not available in that year.


#### Cash Donations

Cash gifts are simple and assuming you can itemize deductions, the tax benefit is easy to determine as it generally reduces your income subject to tax by the amount of cash you donate. To claim a deduction in 2023, the contribution must be made on or before December 31, 2023.

#### Non-cash Donations

While cash is easy to donate, cash may not give you the most benefit from a tax perspective. It, of course, depends! Two "win-win" ways to donate include donating certain appreciated stock and making qualified IRA distributions. First, donating investments that might otherwise generate long-term capital gains if they were sold may allow you to claim a deduction for the fair market value of the stock without paying tax on the long-term gain as if you sold it. If you are considering harvesting some gains in your portfolio before year-end, this might be a good choice. Secondly, if you are over 70 ½, you may be able to distribute up to \$100,000 from your IRA to the church without including the distribution in income.

filled with the Holy Spirit – has the incredible power to change people and to change the world...and it's the only thing in the world that does. anything any one of us could do by ourselves. Our financial support of this church – of our church – is important. And y'all know that we don't talk about money a lot around here because we believe that there are bigger things that need to be talked about...but our financial support is important.

And what we need to understand is that the church is not just one of many charities vying for our support. If we take the Bible seriously (and I certainly pray that we do), God says that it's critical for us – as an act of faith, as an act of gratitude, as an act of trust – to return to Him His tithe: the first tenth of what we make: realizing that He's the reason that we make anything at all. It's all an act

of stewardship: an awareness that none of what we have is ours – not our money, not our stuff, not our time, not our skills...not even our families. They've all been given to us by God., and they've been entrusted to us for a reason. We are here for a reason, and we have what we have for a reason – a sacred and holy purpose. And something beautiful happens when those two combine: our purpose and our provisions – not feeling compelled by what God wants from us, but inspired by what He wants for us...and for others: for us to be a church of real people making a real difference...a church fired up in the Spirit – diving in, going deep, finding faith and finding life like we've never lived before!

# Olternating the Standard and Itemized Deductions

For some of you, your itemized deductions will never exceed your standard deduction. Perhaps some planning could help. While it is not always feasible, if your situation allows you to make your 2023 donations and perhaps pay other deductible expenses for 2023 in this year, your itemized deductions may exceed the standard deduction in 2022 and gain incremental tax benefit to your donations. You would then simply use the standard deduction next year assuming your itemized tax-deductible items would be much lower. This strategy has been referred to as "doubling up," "bunching," or "grouping" your annual deductions.

# Donor advised Funds and Trusts

Perhaps you are familiar with the above, but you have recently seen a Facebook ad talking about "donor advised funds." Donor advised funds (DAF) can be useful and are very flexible. Using a DAF can simplify and accelerate your tax deductions while at the same time allow you to donate a variety of more complex assets (cash donations work as well) and you can generally control the timing and recipients of the grants from the fund.

### Estate and Trust Planning

For longer-term planning there are even more opportunities to give and benefit your tax situation. While too complex to go into here, there are ways to get current deductions by using charitable trusts or similar arrangements – the income from assets can be used now by the donor but the assets are committed to the church in the future. Also, starting in 2023, you can make an election to donate up to \$50,000 to the church by setting up a qualified charitable remainder trust.


### Taxidermy Property












(Donor Advised Funds) Donate cash, stock or non-publicly traded assets to a donor advised fund for an immediate tax deduction. Donations can then be made to a qualified charity of your choice.
